#### Automatic Delivery

#### Loyalty Credits (Both Plans)

It is our goal to reward our loyal customers. You earn \$50 for each year you purchase a Service Plan (up to a total of \$500 during your lifetime as our customer). You can use a portion of these credits toward the purchase of a variety of heating and cooling equipment; the figures below show how much can be used for any one item. Credits are not transferable. They have value only as a credit toward the following equipment purchased from Weaver by Weaver customers.



#### Pre-Pay Plan

Our Pre-Pay Plan is for customers who prefer to lock in their fuel costs at a specific price. By paying for your fuel in advance, the price can be fixed on the amount of gallons you choose to order.

#### 12-Month Budget Plan

Fuel prices may go up or down. Winter temperatures can set records. And there's really no way to predict what weather each year may bring. That's why we've developed a plan that will make things easy for you. Our 12-Month Budget Plan lets you spread your heating costs into smaller, predictable payments.



### Weaver Fuels' General Conditions and Exclusions

1. A tune-up will be performed once during the Service Plan term, during regular working hours, as scheduled by our service department. We will: \*Replace oil filter cartridge and burner nozzle, if necessary. \*Clean and check electrodes and nozzle assembly. \*Oil all motors on burner, fans, and circulators. \*Safety check all operating controls. \*Inspect combustion chamber. \*Vacuum interior of boiler (or furnace) and smoke pipe, including chimney base if necessary. \*Adjust system for maximum efficiency and perform combustion efficiency test to check results.
2. Labor is covered only for repair and replacement of listed parts. For all other work, labor will be charged at our normal hourly rates.
3. Exclusions: This agreement does not cover parts or labor, secondary or consequential damages, when failure is due to: \*Inadequate boiler room ventilation. \*Lack of oil when delivery has been delayed due to delinquency in payments or when customer is not on automatic delivery. \*Failure of customer to maintain proper boiler water level. \*Emergency switch in "off" position. \*Any parts not expressly included in this Plan, or defective or obsolete parts. \*Vacant or unattended premises. \*Changes in oil consumption. \*Piping not related to the heating system. \*Fuel flow problems with outdoor, above ground storage tanks.
4. This Agreement does not cover electronic air cleaners; electrostatic air filters; power venter; humidifier; domestic hot water coil and cleaning; indirect water heater; draft inducer; mechanical or electric water feeder; low water cut off; water heater tanks; steam piping; domestic plumbing; domestic wiring; cooling equipment; repair or replacement of obsolete parts which are not available through regular sources of supply; any system located on rooftops, in crawl spaces, or in other locations that present unusual difficulty in servicing; or any work which requires us to expose concealed piping, duct work, or oil lines for repair.
5. This Agreement will be void if: all fuel oil requirements are not purchased exclusively from Weaver Fuels; if customer cancels automatic delivery status; if customer procures heating equipment service or has equipment installed from any other person other than an employee of Weaver Fuels; if initial payment for plan is not received within 30 days of the plan start date; or if customer fails to maintain an acceptable credit rating. In the event of cancellation, no refunds will be made on any fraction of a year for any unused portion of the plan.
6. This agreement does not cover damage caused by power interruptions, wars, acts of God, accidents, fire damage, flooding or other water damage, freezing, government regulations, strikes, riots, etc., except that which is caused by ordinary wear and tear. \*SERVICE HOURS - During the life of this Agreement, Weaver Fuels will provide dependable, prompt emergency service seven days a week, 365 days a year. All other services will be performed during normal working hours, Mon-Fri, 8am-4:30pm.

7. There shall be no liability for any reason on the part of Weaver Fuels for work done by anyone else, unless such person is authorized in writing by us to perform such work or furnish parts. Weaver Fuels shall not be held responsible for any damage or injury caused by failure or delay in performing services when such a failure or delay is due to causes beyond our control.
8. Customer and Weaver Fuels agree that there are no promises, terms, conditions, or obligations between the parties which are not already contained in this plan. Statements made by sales personnel which are not contained in this plan have not been relied upon by customer and are not party to this plan.
9. Fuel tank allowance applies to any residential above ground heating oil storage tank. Customer shall be responsible for the condition and maintenance of the fuel oil tank. Weaver Fuels assumes no liability for same. This plan does not insure against tank leakage or any damages to persons or property, the atmosphere, any water course or body of water resulting from tank leakage. This plan does not cover any installation, cleanup, removal, remedial, or other costs of compliance with any environmental or other laws, rules or regulations. Weaver Fuels shall not be liable to render any service for which it is not licensed. In no event shall Weaver Fuels' liability for any such damages exceed the allowance of the service plan purchased. Customer is responsible for compliance with all laws requiring notice to government agencies or officials in the event of a leak from the fuel tank.
10. Weaver Fuels reserves the right to reject any equipment from coverage should the inspecting service technician find it to be unacceptable.
11. The length of this Agreement is one year from date of acceptance. It will automatically renew at that time unless we are notified of cancellation in writing 30 days prior. Renewed plans are subject to price and coverage changes.
12. If customer moves, this plan may be assigned to the new owners, provided the new owners agree in writing to assume this plan, all customer's outstanding bills are paid and customer gives Weaver Fuels written notice at least 10 days before the closing.
13. In addition, the Service Plan may include the TankSure® Program which provides a tank testing service and the TankSure® Program Limited Warranty. An ultrasonic tank test will be performed by our technician before your tank can be accepted for enrollment in the TankSure® Program. While we cannot guarantee the prevention of a leak or other failure of your tank, we are providing these new services with the hope that by testing and monitoring, we are offering a long-term proactive tank replacement program for our customers. We recommend that an annual test of your fuel tank be performed. If a tank leak occurs due to corrosion once you are on the program, if a tank leak occurs due to a manufacturer's defect, or if a non-leaking tank is identified for proactive replacement by the TankSure® Tank Analysis Software the Company will pay up to \$1,000 toward the replacement of your tank in accordance with the terms of the TankSure® Program Limited Warranty. A Warranty Certificate will be provided to you.


### Commitment to Service
